**Party Rules and Regulations**

- Alcoholic beverages and tobacco products are strictly prohibited within the facility.
- Pavilion rentals are allowed to bring in their own food and drinks.
- **The total headcount must include all attendees, including adults and non-swimmers. The maximum occupancy for Oasis parties is 25 people.**
- A **two-week** written notice is required for any changes, cancellations, or refunds before the scheduled party date. No changes, cancellations, or refunds will be granted after this period.
- If the party is held during normal operating hours, all pools and facilities will remain open to the public. Private and after-hours events are available upon request.
- Use of the facility is limited to the designated rental space and time outlined in the rental agreement. Any use beyond this is prohibited and may result in removal from the premises.
- The hosting family **may arrive at the start of the reserved rental time**, which includes setup and cleanup. All decorations and personal items must be removed from the Oasis area by the end of the allotted party time.
- Failure to pay fees and surcharges or violation of these guidelines may result in suspension of future rental privileges.
- Renters are responsible for leaving the facility in the same condition as it was found. Failure to do so may result in forfeiture of the **\$150 security deposit**.

## Facility & Safety Rules

- Fins, masks, snorkels, nose-covering goggles, inflatable floats, and outside toys are not permitted.
- Children that require a lifejacket, non-swimmers, and children 5 and younger must always have an adult guardian within arm's reach in the water with them. Lifejackets must be U.S. Coast Guard approved and are not permitted on any water slides.
- Appropriate swim attire is required: gym/athletic shorts, demi cutoffs/shorts, street clothing, t-shirts, etc. are not permitted.
- **All children under the age of 3, or not potty trained, must have a swim diaper** and their swimsuit per Cherokee County Health Department regulations. **Swim diapers can be purchased at the front desk if needed.**
- Children under the age of 14 are required to have a supervising adult (16 years of age or older) with them on the same pool deck at all times.
- Lifeguards are there ONLY for lifesaving and safety purposes. You will need to provide adult supervision.
- Cherokee County Aquatic Center is not responsible for lost or stolen articles; please secure all valuables.
- Weather can be unpredictable and although we try to remain open some conditions will call for temporary closure due to severe weather warnings as deemed appropriate by the Aquatic Center staff.
- In the case of severe weather, parties will be handled depending upon the situation at that time. We will do our best to accommodate accordingly. Since weather can be unpredictable the applicant is agreeing to the party understanding that if inclement weather takes place parties might be moved inside or put on hold until passed.

## Reservations

- All Oasis Paradise Package party reservations are available on a **first-come, first-served** basis.
- To secure a reservation, hosts must have a **completed agreement on file** and **full payment submitted**.
- Agreements and payments must be submitted in person at the **Aquatic Center front desk**. Accepted payment methods include **cash, check, or credit/debit card**. A **2.85% transaction fee** applies to all credit/debit card payments. Checks must be made payable to **CCBOC**. Payment over the phone is not accepted.

## Security Deposit

- A **\$150 refundable security deposit is required** by the Cherokee County Recreation and Parks for all rentals.
- The security deposit must be **paid on the day of your event in cash or check only**, directly with CCAC staff in the lobby (not at the window), and is processed separately from the party reservation fee.
- The deposit will be refunded if the Oasis pavilion is returned in its original condition, reasonably clean, and free from damage.
